Due to the interconnection between financial systems and the resulting risks of crisis, international cooperation between supervisory authorities on banking and financial matters has become essential.

Cooperation on supervisory matters has evolved considerably at a European level, especially with the introduction of new arrangements for both horizontal and vertical cooperation under the Banking Union, whereas issues surrounding cooperation with Third countries have been intensified by Brexit.

As for sanctions, cooperation is equally crucial, whether in the area of antitrust, anti-money laundering or market abuse, and it raises sensitive questions about the protection of sovereignty.

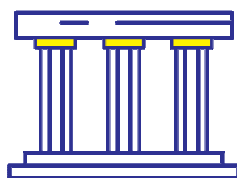
